OUR "A BRUSH WITH KINDNESS" PROGRAM PRESERVES AND REPAIRS EXISTING HOMES FOR SENIOR CITIZENS, DISABLED AND VETERANS. DURING THE YEAR ENDED JUNE 30, 2024, TWENTY-THREE ABWK AND NEIGHBORHOOD PROJECTS WERE COMPLETED AND FOUR COMMUNITY OUTREACH EVENTS WERE OFFERED.
